- 1) Cancellation on the Applicants part requires one (1) calendar months' notice in writing or one full term if cancellation is made in term four (4).
- 2) I acknowledge and agree that this document, when signed by me, constitutes a firm and binding acknowledgement, undertaking and commitment assumed by me in terms hereof.
- 3) My liability arising here from is not subject to any condition whatsoever and this document signed by me constitutes its own unconditional cause against me independent of any other cause. I hereby choose my domicilium citandi et executandi the address mentioned above, at which address all notices and/or processes in terms of or arising out of this acknowledgement of debt may validly be delivered to or served upon me.
- 4) I expressly waive and renounce legal benefits and exceptions non numeratae pecuniae, non causa debiti, errore calculi, and I declare myself to be fully acquainted with the meaning and effect of these exceptions and of the renunciation of the benefits thereof.
- 5) For the avoidance of doubt, this agreement will terminate when your Child completes the School's curriculums and any exit examination we offer at the end of your Child's schooling, unless otherwise terminated on the terms of this agreement. This agreement therefore has an indefinite term.
- 6) The school shall be entitled to instruct Attorneys/Debt Collectors to attend to the collection of outstanding accounts and the persons responsible for the payment of the fees will be liable for the payments of all cost incurred.
 - a) First month of missed fees – written warning – via email/whatsapp.
 - b) Second month – student/s will be suspended.
 - c) Third month – your account is handed over.
- 7) I/we consent, in terms of Section 45 of the Magistrate's Court Act, 1944, to the non-exclusive jurisdiction of any Magistrate's Court having jurisdiction in terms of Section 28 of that Act, notwithstanding the fact that the value of the claim or the matter in dispute might otherwise exceed the jurisdiction of the Magistrate's Court.
- 8) Protection of Personal Information Act (POPI)
